

Central New Mexico Community College/Albuquerque Police Department Articulation Agreement

The purpose of this agreement between Central New Mexico Community College (CNM) and the Albuquerque Police Department (APD) is to grant academic credit to individuals who successfully complete the APD basic officer's accreditation training program, The Police Service Aid training program or the Citizen Police Academy. This training requirement is to satisfy the credit hour requirements established by state law. CNM personnel have reviewed the training program curriculums and the qualifications of the Academy instructors and have determined that selected Academy courses are appropriate for CNM credit. The Academy will maintain grades and records as required by CNM. To receive CNM credits, the certified officer must:

- (1) Have successfully completed the Law Enforcement Academy after 1 January 2007 and the Police Service Aid Academy, or the Citizen Police Academy after January 1, 2010
- (2) Be enrolled in Central New Mexico Community College as a Criminal Justice major.

Individuals who have successfully completed the APD Academy and who meet the other requirements of this agreement shall be awarded full credit for the following Criminal Justice core courses:

CJ 1001-Introduction to Criminal Justice	3 credit hours
CJ 1002-Criminal Law	3 credit hours
CJ 1580-Patrol Practices	3 credit hours
CJ 1007-Criminal Procedures	3 credit hours
CJ 1518-Report Writing	3 credit hours
CJ 2505-Community Policing	3 credit hours
CJ 2515-Criminal Investigations	3 credit hours
FITT 1792-Personal Fitness	1 credit hour

Credit will be given for up to 22 credit hours toward the Associates of Applied Science degree in Criminal Justice. Individuals must complete CJ 1502- Juvenile Law, CJ 2692- Criminal Investigations Lab, CJ 2511- Correctional Services, CJ 2999- Criminal Justice Capstone and nine Criminal Justice Elective hours as Criminal Justice core requirements. Beyond these minimum requirements, CNM will enforce its own matriculation and graduation requirements as required for admission and the award of a degree.

Graduates of the Police Service Aid Academy and who meet the other requirements of this agreement shall be awarded full credit for the following Criminal Justice core courses:

CJ 1001 Introduction to Criminal Justice 3 credit hours
CJ 1518 Report Writing 3 credit hours
FITT 1792 Personal Fitness 1 credit hour


Graduates of the Citizens Police Academy and who meet the other requirements of this agreement shall be awarded full credit for the following Criminal Justice core courses:

CJ 1001 Introduction to Criminal Justice 3 credit hours

The Academy agrees to the following:

- (1) Notify CNM within thirty (30) days of any changes to their training program.
- (2) Participate with CNM in Criminal Justice Program information dissemination, marketing and recruiting activities.


Either party may terminate this agreement, with or without cause, by providing thirty (30) days written notice. The terms of this agreement shall continue in effect for any students who enroll under this agreement prior to termination or until the student graduates or withdraws. This agreement shall be reviewed annually by both parties for possible revisions.
