List of Required Documents for requesting CPL for HLTH 1001:

1. A completed, signed CPL Health 1001 – Clinical Preparation Form (this form),
2. Proof of \$25 fee payment (you may take a completed copy of this form and pay in-person at the CNM Cashier, or you can pay online through the [CPL store](#) and print/save a copy of the receipt to attach to your request with all other documents),
3. A copy of your government issued ID,
4. A current, valid Professional Healthcare Provider level CPR card that meets Emergency Cardiac Care (ECC) guidelines developed by International Liaison Committee on Resuscitation (ILCOR) and required traditional face-to-face course or a blended online/skill session process to be certified (only those listed below are accepted), **and**
5. Proof of current certification or credentials in current Bloodborne Pathogens training, HIPAA, **and** Infection Control. Proof of this training can be obtained from a current employer or in the form of certificates earned upon completion of online or in-person training programs.

Licenses and/or certifications are checked for validity through their corresponding agency.

Incomplete or invalid requests will not be processed.

If you have the following credentials (4 documents total), you will receive credit for HLTH 1001 – Clinical Preparation (1 Cr):

1. Professional Healthcare Provider level CPR cards which use current ECC guidelines developed by ILCOR. In order to meet this standard and be considered for credit, proof of CPR certification must be provided from one of the training agencies listed on this document. Furthermore, all healthcare provider level CPR credentials on this list show proof of hands-on CPR skill training and under no circumstances will CPR training that is conducted only online be accepted. The only acceptable CPR credentials that meet this standard are listed here and any credential not on this list will not be accepted.

- American Red Cross "CPR/AED for the Professional Rescuer," or
- Emergency Care and Safety Institute "Professional Rescuer CPR," or

- American Safety & Health Institute "CPR for the Professional Rescuer," or
- Military Training Network "BLS Healthcare Provider," or
- EMS Safety Services "CPR/AED for the Professional Rescuer"
